

## REFEREE ASSAULTED

### Scenes at East Limerick Hurling Final

#### Spectators Invade Pitch

Disorderly scenes marked the close of the final of the East Limerick Division Hurling League, between Ahane, Co. Champions and Fedamore at the Gaelic grounds, Limerick, on Sunday, at the conclusion of the game, which was won by Ahane on the score—Ahane, 12 pts.; Fedamore, 1 goal 1 point. A crowd invaded the playing pitch and assaulted the referee, Mr. J. Roche Croom. Despite the efforts of a number of players to protect him, Mr. Roche received a blow of a hurley across the head. He left the field with blood streaming down his face from a nasty head wound.

Up to a quarter of an hour from the end the game, though close, was cleanly contested. Then in some hectic mid-field exchanges tempers became frayed, and the referee sent J. Mackey (Ahane) and P. Clobessy (Fedamore) to the sideline. Five minutes later another incident resulted in a third player, M. Malone (Fedamore) receiving marching orders. After his he game proceeded quietly to the finish, when the trouble as described above began.

Ahane by their victory qualify to meet the winners of the western division in the county final. Although playing against a strong breeze, Ahane were first to attack, and Tim Ryan pointed in the third minute. Despite stout Fedamore opposition Ahane continued to press, and before the interval they had five further points, Mick Mackey (4) and Herbert being the scorers. Fedamore's only register in this half, a point, was scored by Clifford.

Three minutes after the start T. Flavin shot a grand goal for Fedamore from forty yards. With only two points in the difference exchanges became hectic. Ahane, however, were clearly superior.

## BOY'S DEATH

### Sequel to Road Accident

#### Cycle and Car Collide

The death occurred at the County Infirmary on Sunday evening of David Breagh (14½), of John Street, as a result of injuries sustained when struck by a motor car near the Fair Green, Limerick, where he was cycling, on Friday afternoon.

Mr. J. S. McNeice, Solr., Deputy Coroner, with a jury, opened an inquest at the County Infirmary touching the death of the deceased.

Supt. Meehan conducted the enquiry, and Mr. D. J. O'Malley, solr., represented the driver of the car, Mr. Martin O'Connor, Summerville Avenue, Limerick.

Mr. John Breagh, John Street, father of the deceased, gave evidence of identification, and said that prior to the occurrence his son was in perfect health.

#### DOCTOR'S EVIDENCE.

Dr. Bridget Crawford, Co. Infirmary, stated the deceased was admitted to the hospital on Friday afternoon. He was unconscious, and on examination she found a fracture of the vault of the skull. Death, in her opinion, was due to shock, following fracture of the skull.

Supt. Meehan, at this stage, applied for an adjournment pending any proceedings that might be taken arising out of the occurrence.

The Coroner acceded to the application and expressed deep sympathy with the relatives of the deceased.

The Jury, Supt. Meehan, and Mr. O'Malley, on behalf of the driver, also expressed sympathy with the bereaved parents.
