LITTLE BOY'S DEATH

Fatal Road Accident

While playing near his home at Ballinagarde, Ballyneety, on Tuesday last, Michael Donnelly, aged 7½ years, son of Patrick Donnelly, was knocked down by a lorry the property of the Condensed Milk Co. of Ireland, and received fatal injuries.

Death was almost instantaneous.

On Wednesday Dr. A. Murnane Power, Coroner, with a jury, opened an inquest into the circumstances surrounding his death at Ballyneety.

After evidence of identification by the deceased's boy's father, and medical evidence had been tendered, the inquest was adjourned, on the application of the State pending further inquiries.

Mr. P. G. Collins, solicitor, Limerick, appeared for the Condensed Milk Co. at the inquest.

RECENT BURNING

Claim for £2,000 Lodged.

In connection with the burning of the residence of Rev. Father Lee, C.C., Doon, a claim for £2,100 compensation has been lodged with Limerick County Council—£1,600 for the house and £600 for Church and other property.

At Pallas Court on Tuesday, a girl from Hollyford, Co. Tipperary, was charged before District Justice Flood with being concerned in setting fire to the premises, and was remanded pending further investigations.

COUNTY DUBLIN DROWNING.

One of the two victims of the Killiney drowning accident which took place on Sunday week last, was recovered from the sea on Wednesday night. The body, that of James Malone, of Grange Hill, Sandyford, was seen floating in the water about 200 yards from the shore at Vico Strand, Killiney, by a railway porter.

There is a great deal too much of this butting in from the Bench and advancing of opinion which nobody wants and doesn't give a hoot for. The personal view goes so far with many of these pundits as to suggest when people should retire to rest or the refreshment they should take or abstain Up the country the other day, from. arising out of applications for extension of hours of dancing, the Justice thought people should go to bed at a reasonable hour and not remain dancing all night. However, he was not going to impose his opinion in the absence of any objection. It is that kind of thing that breeds conempt for authority; the people are not going to have their lives regulated for them, no more than to be regimented. They know where to draw the line and how to comport themselves.
