TAUGHT IN LIMERICK

Christian Brother Fatally Injured

Rev. Brother Thomas S. Condon, of St. Mary's Christian Brothers' School, Clonmel, was fatally injured by a motor car a mile outside the town of Clonmel on Thursday evening. He was walking alone at the time of the accident, and was found to be dead on the arrival of medical assistance, which was immediately summoned.

The motor car, it is said, was being driven by a well-known amateur jockey from Co. Kildare.

Brother Condon, who was 58, was a native of Ballindangan, Mitchelstown, Co. Cork. He was 43 years in the Christian Brothers, and had been in Clonmel about 5 years. Prior to that he taught in Limerick for more than 20 years.

On the application of Supt. Kelly, an adjournment was granted at the inquest.

Medical evidence showed that death was instantaneous, and was due to dislocation of the neck.
