"To L. J. Duffy, Esq., Sec. Labour Party.
"Nationalisation of Transport and
Superannuation for Rail Men.

"A Chara,-In connection with the above, I refer you to my previous correspondence, and to point out that as a result the Government are about to introduce legislation to ease the situation developed through the various defective Acts that have been passed, and which have almost bankrupted rail transport. You will agree that the Amalgamation Act offered an outstanding opportunity to the Trade Unions, when in its initial stages, to obtain a suitable superannuaton for railwaymen. Yet, notwithstanding their connections with a strong Labour Party, a miserable clause was embodied throwing the railwaymen on the clemency of the Railway Company, and was so bad that the then heads of the Labour Party apologised to the men who promoted the movement.

"Again, in the Transport Act, the same position arose. Another superannuation clause was passed, which was even worse than the first-in fact, the Judge appointed under the Act turned it down; yet, as I have already stated, the Unions, with practically unlimited resources at their disposal, strong legal assistance, close contact with the Labour Party, failed through inactivity to avail of those opportunities. Similar opportunities are about to develop now, as the Government are about to amend the Transport Act, or introduce a new Bill, thus giving the Labour Party and the Unions concerned an opportunity to retrieve their past and to have the superannuation clause in the Transport Act | amended, and to press for nationalisation .nf transport, abolishing private ownership (see draft of Scheme for Nationalisation-Rail, Road, Air, and Water, which I officially handed to you, and to all members of the Government).

A strong virile campaign on these inter it ues by the Labour Party and the Rail Unana will infuse new life into the Labour movement generally, and the Railway Unions in particular. My Commiline suggests a strong Advisory Committee, composed of men who have made a study of transport and with practical experience, with expert logal assistance, be set up to consider any new legislation and to advise the Labour Party during the passage of same through An Dail. We believe that up-to-date methods should be availed of to ensure that future logislation dealing with transport, and the superannuation scheme for its controyers, should not be handled in the she bud manner of the past, when the Ra Companies directed legislation to private control, irrespective of necessary steps would be taken at once to enact legislation, and it was anticipated as a result that the tourist industry in the country would be increased to an enormous extent.

The Gaelic version, "Grianan na Seacht n-Eochrach," will be staged by the Limerick Gaelic Dramatic Society early in November.
