### STATEMENT BY VATICAN RADIO.

Soviet Russia has drawn up black-lists of Catholics in countries throughout the world, comprising a total of some 4,000,000 names said a Vatican radio broadcast on Tuesday night.

About 2.000,000 of those listed are Germans, it was stated.

"The Slovak list includes the name of Father Tiso (the Slovak President)," the announcer said.

"The Polish list is the most complete of all, which probably accounts for the wholesale executions in the Soviet-occupied part of Poland.

There is even a Japanese list. Nothing, however, is known of a United States list, this, no doubt, being due to the clause under the Soviet-U.S. agreement, by which the Soviets promise to refrain from propaganda in the States."

## DEATH OF MR. JAMES S. DOYLE, SOLICITOR.

The death occurred in a Dublin Nursing Home yesterday of Mr James S. Doyle solicitor, Limerick. The deceased, who retired from practice about six years ago, was admitted a solicitor in 1884, and enjoyed an extensive practice in the city and county. He was son of the late Mr. D. Doyle, solicitor, a prominent figure in the '48 Repeal Movement. He was a brother of the late County Court Judge Charles Doyle, and of the late Mr D. S. Doyle, Assistant Registrar-General.
