### Limerick Man Fined

### Accident Near Killaloe

Mr. D. F. Gleeson, District Justice, adjudicated at Killaloe District Court. Sergeant James McGuinness had Christopher McNamara, 29 Wickham Street, Limerick, fined 20s. for driving an untaxed motor car at Church@Street, Killaloe, on the 10th April. The defendant had received the usual notices requesting payment before April 7th.

The Attorney-General summoned Hubert Veller, a nationalised German, of Mountshannon Co. Clare, and Francis Glynn, the Crescent, Limerick, for dangerous driving at Ronlagh, Ballina, Killaloe, on 3rd April.

Mr . A. Blood-Smyth, solicitor, appeared for Veller, and Mr. D. J. O'Malley solicitor, for Glynn.

Guard P. Hyland said as the result of a report from Mr. Veller he went to Ron-Ballina, and near the Templelagh, hollow graveyard found two motor cars. Mr. Veller was driving to Limerick from the Killaloe end, and Mr. Glynn was coming from Limerick at 9.5 a.m. The road was 19 feet wide at the place. There was a bend about 20 yards from the graveyard, and there was no view until one dame to the graveyard from Limerick end. Mr. Veller would have a view of 136 yards. Mr. Glynn's car was on the centre of the road; his right front wheel was 13 feet from the side. Both gentlemen stated that a donkey cart was being driven in the direction of Ballina, Killaloe. Mr. Glynn went to pass out this vehicle. He saw Mr. Veller's car, and was unable to pass out or get behind the donkey cart before the motors collided. Mr. Glynn had Anthony O'Donoghue, of Newport, as passenger in his car. He applied his brakes, and thought the other driver would slow down to give him time to get behind the Mr. Glynn, who is manager of Messrs John Crotty's, Killaloe, was coming to Kilaloe, and the other man had a business at 22 Thomas Street, Limerick.

To Mr. Blood-Smyth-The spot was 20 yards on the Killaloe side of the bend. Mr. Glynn did not pass the donkey cart. P. Mooney, Summerhill, Ballina, the driver of the donkey cart, said the first thing he noticed was the car from Killa'oe way coming fastly over the Mill River bridge; he did not see the car behind; he did not hear a horn sounded by either driver. When Mr. Glynn's came up to him it was going too slow to pass or drop behind.

To Mr. Blood-Smyth-If Mr. Glynn's car was in behind the donkey cart there would not have been an accidents

To Mr. O'Malley-If Mr. Veller eased down it would also have prevented a collision.

Anthony O'Donoghue said ten yards from the bend he saw the donkey cart. Mr. Glynn slowed down and pulled out to pass the cart. He was driving at about 15 miles an hour.

Hubert Veller said he was going at a normal rate, and accelerated a bit to get up the hill. He would be travelling at about 25 miles an hour. He had been

## Malicious Damage Award

### Workman's Injuries

At the Limerick Circuit Court on Monday, before Judge E. J. McElligott, ville, O'Connell Avenue, of Mrs. Margar John Higgins, Mulgrave Street, Limerick, claimed £5 3s. 9d. from the Line. rick Corporation in respect of damages to a plate-glass window on 17th November last.

The claim was brought under the Malicious Injury Act.

Mr. J. Dodds, solr., appeared for the plaintiff and Mr. J. J. Dundon, solr., for

Sergeant J. Gahan said that on the night in question he found a man outside plaintiff's premises whom he arrested, and charged with drunkenness and malicious injury to a plate glass window. The man was sentenced to six months hard labour.

#### WORKMAN INJURED.

Denis Daly, Boherbuoy, Rathkeale, applied for £1 2s. 6d. a week under the Workmens' Compensation Act, against the Limerick County Council in respect of injuries received to his left eye while breaking stones for the defendants

E. Cussen, solr.), appeared for applicant, and Mr K. Liston, B.L (instructed by Mr. R. O'Sullivan, solr.) for the County Council.

Applicant, in evidence, said that his left eye was injured while breaking stones for the Co. Councl The injury was treated for ten days As a result of the injury he would not-now be able to do the work he was doing formerly. His eye pained him now and again and his sight was defective.

Dr. C. McDonnell said that the condition of the applicant's eye to-day was much the same as when he left hospital. There was a partial cataract in the eye, which would be permanent.

For the County Council, Dr. S. O'Malley said she examined Daly on the 18th February and found the sight of the eye defective. His present condition was much the same as it was in February, but it had improved in external appearance. She thought he was quite capable of doing ordinary work.

His Lordship said that the percentage of injuries to workers' eyes in Limerick was much greater than in Clare or Kerry. The amount of compensation claimed was 22s. 6d. per week, but he did not think he was entitled to that much. Hes would award a sum of 16s. per week on the basis of partial incapacity.

His Lordship allowed £3 8s. expenses and £5 medical expenses.
