Dr. F. W. Kennedy

We regret to announce the death of Dr. Frederick W. Kennedy, which occurred at a London Nursing, Home on Thursday last. He was 77 years of age, and on retirement from practice in Limerick in 1933 he went to live in London where his two sons are engaged in mercantile careers. Dr. Kennedy was educated in Trinity College, Dublin, where he obtaned his degree, and soon after entered into practice in his native city, at Pery Square. He rapdly extended it, and numbered amongst his patients some of the most influential people in the city, as well as in the county and Clare. He was for many years on the honorary visiting staffs of the County Infirmary and the Maternity Hospital, Bedford Row, as well as Court Medical Assessor under the Workmen's Compensation Act. In early life Dr. Kennedy was an accomplished cricketer; he was a member of Limerick County Lawn Tennis and Cricket Club, and played for Munster and the Gentlemen of Ireland. He was a very clever surgeon, kindly and charitable and extremely popular with the citizens and the profession. He is survived by his widow, a daughter of the late Mr. R. O'Brien Studdert, Cullane Castle, Kilkishen.
