The Funeral

The death occurred at the Good Shepherd Convent, Limerick, on Sunday morning of Mother Mary Columba Cahill. The passing of this esteemed member of the Limerick Community will be widely and sincerely regretted. She was a gifted lady; who had spent the exteremely long period of 63 years in religion. That her gifts were appreciated to the full was evident from the fact that she acted for a number of years as Mother Provincial of the Order. In this latter capacity she travelled to France and Italy on her visitations to the houses of the Good Shepherds. In May of last year she celebrated her Diamond Jubilee as a nun, an event rare in the lives of religeuse.
