Death of Rev. T. Nolan, of Kilteely.

# Monsignor's Brather.

The death occurred at the Parochial House on Saturday night of the Rev. Thomas Nolan, P.P., Kilteely. County Limerick.

Born at Killenaule, County Tipperary, the late Father Nolan was educated at Thurles College, where he was ordained in 1897. After his ordination, he went on the English Mission, was recalled after about 12 years, and was Secretary to Most Rev. Dr. Fennelly, Archbishop of Cashel, for two years.

After filling curacies at Boherlahan and Kilteely, he was, in 1934, appointed Parish Priest of Kilteely, and was responsible for clearing a parochial debt of £1,200 in that parish. During the troubled period, Father Nolan ministered to wounded men, following the Drumkeen Ambush.

Deceased was brother of Right Rev. Monsignor Nolan, P.P., V.G., Tipperary.

At the removal of the remains to Kilteely Church the large cortege of clergy and laity testified to the deep sense of sorrow which his death evoked.
