### MR. DAN D. COLLINS, ABBEYFEALE HILL.

The death of Mr. Dan D. Collins, of Abbeyfeale Hill, succeeding an operation, came unexpectedly to his bereaved family and his many friends at the comparatively early age of 58, and after little more than a week's illness. The matter was not further discussed.

### FIXTURES MADE.

The Council then proceeded to make fixtures, the fixing of the re-play of the drawn game between Limerick and Waterford being the principal item on the agenda.

The referee, Mr. Phil Purcell, in his report of the drawn game at Killarney, said:—"It was a good, clean, well-contested game, ending in a draw, and he had no trouble with the players."

Several delegates, together with the Chairman, endorsed the statement of the referee.

The Chairman said the only disappointment was the small attendance, which had patronised the game, the attendance being one of the smallest they ever had for a Munster Championship.

Mr. J. J. Sheehy (Kerry) said it was undoubtedly a very fine game, but it was unfortunate that the fixture should have clashed with the Carnival at Tralee.

Following a discussion, Clonmel was fixed as the venue of the replay on the 14th July by six votes to five for Cork Athletic Grounds. In a first poll the voting was—Clonmel, 6 votes; Cork, 5; Killarney, 2. Killarney having been eliminated, Clonmel received a majority of one vote, the Chairman stating that he would then have to give a casting vote and he declined to do so.

Mr. M. Hennessy or Mr. Seumas Burke (both of Clare) were appointed to referee.

It was agreed to postpone the senior football final from the 14th July to the 21st July, the venue to be—If Clare v. Tipperary or Kerry, at Ennis; if Waterford v. Tipperary or Kerry, at Waterford.

The junior hurling final was fixed for Fermoy on the 21st July, no matter what counties were engaged. The junior football final, also on the 21st July, was fixed as follows—If Cork v. Tipperary or Waterford, at Fermoy; if Clare v. Tipperary, at Ennis.
