## OBITUARY

MRS. JACKSON, FOYNES.

The death of Mrs. Jackson took place at her residence, Foynes, on Wednesday evening June 12th. She was the wife of Mr. Patrick Jackson, Secretary of the Foynes Branch of the Irish Transport and General Workers' Union and Treasurer of the Foynes Development Association, and mother of Risteard Mac Siacus, who is Manager of Messrs. Tedcastle McCormack and Company, Foynes, and Secretary of the local Gaelic League club. The Jackson family has been identified with national, social and cultural development since the early days of Sinn Fein. The late Mrs. Jackson taught in St. Mary's Convent in Limerick and in Foynes National School prior to her marriage. At the Oireachtas in 1903 she was granted a first-class certificate for teaching Irish, which was signed by Dr. Douglas Hyde, now President of Ireland, and by Patrick Daly, who was then the General Secretary of the Gaelic League. Very Rev. Canon Rea, P.P., V.F., attended her Gaelic League classes when a curate in Limerick. It is not surprising to find that her family followed in her footsteps. Her elder son, Risteard, is a keen Gaelic student and was one of the sponsors of the Coisde na bPaisdi scheme in Limerick. The Gaelic League was represented at her funeral by Messrs. Donncadh O'Brien, T.D.; Padraig O'Carroll, Michael Tuohy, and Thomas de Villiers. Prominent among the general public were Mr. J.
