WATER & SEWERAGE

Position In Hospital

ATTITUDE OF DEPARTMENT

The attitude of the Department regarding the relation between water and sewerage schemes came up for discussion at a meeting of the Limerick County Board of Health on Friday, Mr. Michael Ryan, Co.C., chairman, presiding.

The Department wrote stating that it was noted that only 7 out of 140 houses in the town of Hospital were connected with the water supply. Until there was evidence that a substantial number of the householders were prepared to avail themselves of the amenities provided the question of installing a sewerage scheme must be deferred.

HEAVY EXPENDITURE FOR SEVEN PEOPLE.

Senator Madden said this was an extraordinary statement. In Hospital the pumping was costing £120 and other incidental expenses ran up to £200. The ratepayers were paying this sum for the accommodation of seven people. That should not happen and the Board should learn from this in dealing with other schemes to see that the major portion of people who sent deputations and made cases for water supplies, were prepared to take in the water, and so lighten the burden on the shoulders of the taxpayers.

Secretary—We'll ask the solicitor to report to the next meeting on the position.

Chairman—We'll send a copy of the letter to the Parish Council of Muintir na Tire there and see what action they are going to take.

Secretary It is the business of the Board to compel them to connect.

Mr. Quaid—The letter from the Minister says he won't sanction the sewerage scheme until connections are made.

The Secretary said that the Board should deal with this matter straight away.

BOARD COULD COMPEL PEOPLE TO CONNECT.

Senator Madden said that the solicitor should set out the number of people willing to take in the water. If people did not the Board could compel them. A number of small places were looking for water. Before the Board embarked on any of their schemes the solicitor should take the essential steps.

The Secretary said that this was being done in the case of all new schemes and that agreements were sent out for signature.

The matter was not further discussed.
