### INTERESTING AND USEFUL SURVEY

The Irish Times review and annual for 1940 has just been issued. This publication is in its seventh year and undoubtedly it has earned a reputation as an invaluable survey of every aspect of Irish life. War-time conditions have necessitated certain changes and additions but the essential character of the publication is unaltered. All the usual features, including that relating to Irishmen in Canada and the United States, have been retained, together with special articles on the Defence Forces of Eire, defence against air attack and the effect of the war on our own country. County surveys summar-
