## By Sealed Order

## NEWCASTLE WEST TOWN COMMISSIONERS

The Minister for Local Government has issued a sealed order dissolving the Newcastle West Town Commissioners and transferring their powers and functions to the Limerick County Board of Health. The members of the Council were informed of the Minister's decision when they assembled for a special meeting called for Tuesday night.

Town Clerk (Mr. P. O'Mahony) read the order issued by the Minister and explained that the Council had now ceased to

exist.

Mr. M. Culhane, Chairman, said there was no alternative but to accept the Minister's order under protest. There was no suggestion against the members or Town Clerk, with the exception of an irregularity in connection with the housing scheme, for what they were not directly responsible. They had done their best in the interest of the town.

position for thirty years.
