The Justice dism'ssed the case. Mrs. Hannon, Maiden Street. New castle West was summoned for a breach of the licensing laws on the 25th June.

Sergeant Daly stated that about 4.10 p.m. he entered the defendant's premises from the back and found a local man in the kitchen who said he had business there, and he found two non-bona-fide travellers in the

bar.

Cross-examined by Mr. R. J. Cussen, solicitor for defendant-The in the kitchen had no drink and he said he was there on some business.

The Justice imposed a fine of £2. and the men on the premises were fined 5s. and 2s. 6d.

LIKELY APPOINTMENT

It is stated that Mr. Thomas O'Donnell, K.C., referde to the Pensions Advisory Committee, is likely to succeed Judge E. J. Mc-Elligott, K.C., as Circuit Judge for Limerick, Clare and Kerry, Noofficial announcement regarding the appointment, however, has yet been made.

Judge McElligott is to retire shortly through ill-health.

Before his appointment as Pensions Referee, Mr. O Donnell was appointed a Circuit Judge without being attached to any particular area. He deputised for Judge J. K. O'Connor, K.C., in the Cork Circuit when the latter was Pensions Referee.

Judge O'Donnell, who is a native of Kerry, began life as a National Teacher. He represented one of the divisions of his native county in the British Parliament as a member of the Irish Party under John Redmond's leadership. He figured prominently in a memorable scene in the House of Commons and on that occasion lambasted the British Government in a speech in the Irish language. This was said to be the first time the House was addressed in Irish. During his membership of the frish Party Mr. O'Donnell studied for the Bar and after his call built up am extensive practice, later becoming a K.C. and figuring in several important cases. Some years ago he wrote and spoke much in favour of strong protection for Irish industries and in support of the demand for reform in our monetary system.
