of a contract, as in this case, there was no obligation on the Corporation to keep the house in repair. The plaintiff was suing for linoleum damaged when rain got in under the door.

Mr. O'Donovan said he could go

no further in the case.

The Justice said it was quite obvious that there was not alone no obligation on the Corporation to keep the house in repair without a contract, but it would appear also that there was no obligation to put a tenant into a premises in a hab table state. In the circumstances he would have to dismiss the case.
