### BIG BOOK STOCK.

The book stock at the City Library, despite the war, continues to grow. At the end of last month there were no fewer than 15,192 volumes available for circulation, as compared with 14,562 books on 31st August. This fact goes to show that the Librarian, Mr. Herbert, is losing no opportunity in making the department entrusted to his care a really live institution. It is to be noted—and with regret . that books of fiction are in popular demand when compared with other classes of literature. For October fiction accounted for 58.3 per cent, of the book issues and non-fiction only 24.2 per cent. Books of reference were relegated to a back seat, the demand representing only 2.3 per cent.
