# TO LATE MR. JOHN QUILLIGAN

High tributes were paid to the memory of the late Mr. John Quilligan at the meeting of the Limerick Corporation last night, the Mayor (Mr. D. J. O'Malley, solicitor) presiding. The other members present were: Ald. D. Bourke, T.D.; Ald. J. McQuane, Councillors P. J. Donnellan, C. V.

The Mayor said that as that was their first meeting since the death of Mr. John Quilligan, who was of their most esteemed officials-probably one of the most esteemed men in Munster-he thought it was only fitting that the Council should mark the sense of his loss. Anything he (Mayor) might say of the late Mr. Jack Quilligan would be superfluous having regard to what had already been said of him by public bodies and the Press. He would only add that a better and truer Irishman than the deceased it would be hard to find. As an official he was the acme, of perfection itself, and as a sportsman he had few equals, if any.

The Mayor then proposed a vote of sympathy with the widow and family and adjourned the meeting

as a mark of respect.
