in the city for dramatic productions. A number of interested parties had been discussing the future of the Athenaeum Hall, but the rent and rates attaching to this building proved too onerous for a Voluntary Cultural Committee. In that connection he would like to know if the hall attached to the Technical Institute would be available dramatic productions.

The Mayor said that the hall attached to the Technical Institute appeared to be under the control of the Chairman of the Vocational Education Committee.

Mr. Donnellan (chairman of the Vocational Committee) said that he would not discuss the matter at that meeting. Mr. O'Malley would get all the information he wanted concerning the hall at the next meeting of the Vocational Committee.

Mr. O'Malley said that if the Vocational Committee was not prepared to act reasonably the Corporation could stop its contributions to the Committee. The Vocational Committee could get out of its difficulties with regard to the letting of the hall by appointing a Cultural Committee to consider applications for the use of the hall.

Mayor-I suggest that you raise the matter at the next meeting of the Vocational Committee, but you will require to be far more persuasive than I proved to be.

Mr. O'Malley-I' will act as you suggest and if necessary I will ventilate the matter here again.
