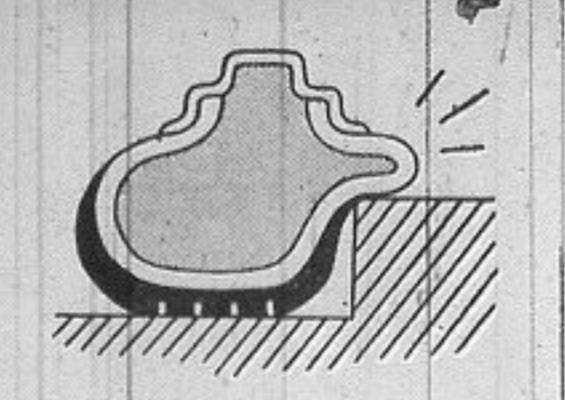

NEW TENANCY CREATED

Joseph Newman, The Square, Dromcollogher, sought before Mr. C. S. Kenny, B.L., D.J., at Dromcollogher Court, possession of a dwellinghouse held by Hannah Curtin, Pike Street, at a rent of 3/- a week. He explained that the Board of Health brought proceedings against him in connection with the house, and he wanted to get possession to carry out the Board's order. He admitted in cross-examination by Mr. Binchy, solicitor for defendant, that it was while the previous tenant was in occupation that the Board of Health condemned the premises. When that tenant left he did some improvements and Dr. McNamara was now satisfied with the condition of the house, and Mrs. Curtin was still in possession and pays the rent. Mr. Binchy, asking for a dismissal, said the tenancy expired on the 26th October last and acceptance of the rent created a new tenancy, which must be determined by another notice to quit. That was the well settled law, he said, and the Justice agreed with him and dismissed the summons. Mr. T. J. Liston, solicitor, appeared for plaintiff.

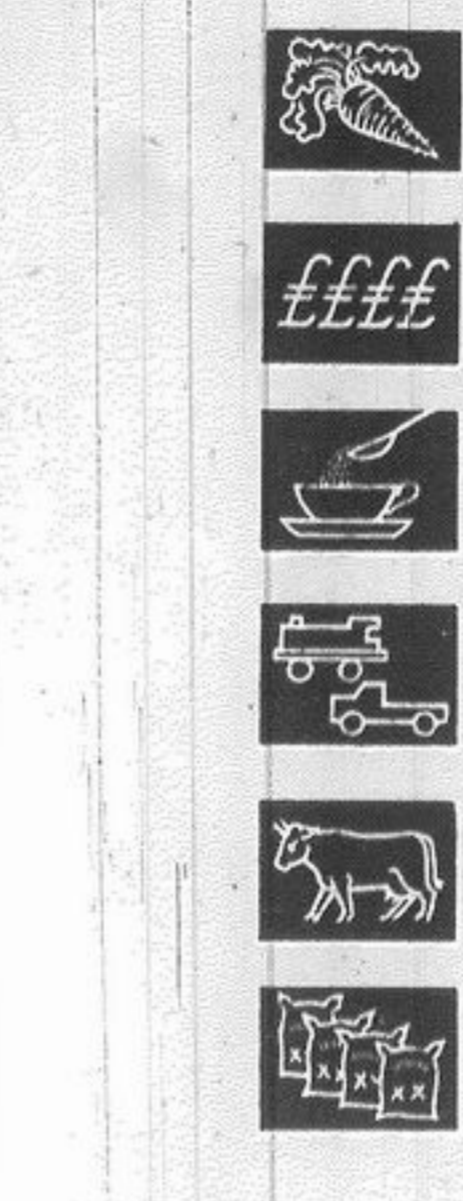
