## CLARE TURF DEFICIT

Reporting to the Clare County Manager (Mr. D. O'Keeffe) on the loss incurred by the employment of urban workers on turf production. Mr. F. Dowling, County Surveyor, stated that the total expenditure amounted to £3,728 3s. 8d. for the production of 2,386 tons, which worked out at £1 11s. 3d. per ton. Charging at the rate of £1 6s. per ton it left a deficit of 5/3 per ton, or £626 6s. 6d., which represented the loss suffered by the Council. The Manager referred the matter to the Minister for Finance.
