Witness considered that the defendant was not travelling too fast at the time.

William Foley, Ballysimon Road, who accompanied the defendant, said that after passing Ballyvarra Cross he observed the cart in front and the defendant swerved out from his correct side to avoid the cart but Ryan was hit by the sidecar of the motor cycle. They were not more than ten yards from the cart when he observed it at first.

Garda Murphy, who visited the scene of the accident, gave evidence of the measurements of the road. THE DEFENDANT.

Michael Wallace, the defendant, said that on the date in question he left Castleconnell at 10.39 to return As he came to the to Limerick. cross he saw the road in front was dark and shortly afterwards he saw the man and cart in front of him. He swerved out to avoid the man but the sidecar came in contact with him and the accident occurred. The Justice said that if the de-

fendant was keeping a proper look out he should have seen the cart before he did. Defendant never had an accident before, and he did not think it was a case of gross regligence. Defendant would be fined fl with 17/6 expenses.
