a very practical and important decision.

During the past couple of years we have repeatedly rereferred to a crippling clause in the constitution of the existing Conciliation Board. The rule in question is one under which the Board could not act unless it were invited to do so by both parties to a dispute. The effect of this absurd and hampering restriction was that the side with a bad case could always take up an attitude that would effectively prevent the operation of "sweet reasonableness."

In the circumstances, therefore, the City Conciliation Board had, through no fault of its own, fallen into a state of "masterly inactivity." For all practical purposes it may be said to have no existence at all, for strikes and disputes of various kinds arose and ran their courses without any reference to it whatever. We repeatedly urged on those responsible for the Board to take some steps to make it effective and we are sincerely glad that our advocacy has not been in vain.

On one occasion we suggested that, failing action by the employers' and workers' organisations, Muintir na Tire might consider the question of forming a new Conciliation Board. The Trades Council, apparently, did not like this idea and we at once agree with the statement made at its meeting by Mr. McDonnell that "the setting up of a Conciliation Board was the business of the employers and employees." The Council, at any rate, has decided to bring the matter before a meeting of the Executive with a view to having the restricting clause referred to removed.

The Limerick Conciliation Board in the past did great work in preserving industrial peace in the city. Rightly pointing this out, Mr. James McQuane stated at the meeting of the Trades Council, of which he is the respected President, that the clause in the rules "whereby the Board had to wait until called upon by both sides in a dispute should be amended so that the Board would have power to intervene." The general feeling of the meeting, indeed, appeared to be, in the words of Mr. C. O'Kelly, N.T., that "it would do great good to have the clause amended.' * * *

The Trades Council on its part, it will thus be seen, is prepared to put the Conciliation Board on a new and much-improved footing. The organised employers, we feel sure, will also approve of the same step. The rule debarring action unless on the invitation of the two sides to a dispute should never have been adopted. Its removal is a matter of urgent necessity and will be the means of giving Limerick a very valuable piece of machinery for maintaining harmonious relations between capital and labour in this city!
