to-day. The time for the redemption of the advance was simply extended—an admirable piece of chicanery from a politician's point of view.

## FOUND DEAD IN MEADOW

Dan Ryan (33), Lissard, Galbally, Co. Limerick, who was missing from his home for three weeks, and for whom a search was made by Gardai and L.D.F. men, was found dead last Sunday about two miles from his home in a meadow field of Mr. Tim Power, Garryspillane (writes our Ballylanders correspondent).

The corpse was discovered by Masters William and Paddy Quish, Newtown, who were crossing the fields to a football match at Garryspillane. Deceased was seen alive near the place where his body was found about seven days ago, and it is believed that death must have taken place shortly afterwards.

Dr. O'Connor, Kilmallock, held a post-mortem examination, and Dr. Cleary, Coroner, Hospital, conducted the inquest.

The funeral took place from Lissard to Emly Cemetery on Monday.

door and witness went to talk to her. Witness had the tongs in his hand at the time. While they were talking defendant came across the street "like a roaring bull" and accused them of talking about him. He struck witness in the mouth and knocked her down and kicked her, as a result of which she had to be treated by a doctor.

Julia Roche said that Hart accused them of talking about him which they denied. She saw Hart with his hands on Mrs. Hart's throat and he kicked her as well. Plaintiff was in a bad way as consequence.

Guard Mahoney said that Mr. Hart complained to him and showed him a mark under her eye where there was blood.

Christopher Hunt said that the witness (Mrs. Roche) owed him fortnight's rent. When he asked Mrs. Roche for the rent plaintiff attacked him with the tongs. In the struggle plaintiff fell to the ground.
