

THE LAND ACTS.

Commissioners O'Shiel, Waddell and Herlihy, of the Irish Land Commission, held a sitting at Limerick City Courthouse yesterday, when a number of applications and objections under the Land Acts were heard. There were five applications from County Kerry under Section 14 of the Act of 1931. There were two applications each from the Counties Limerick and Clare, and four objections under Section 43 of the 1923 Act were heard. The solicitors engaged were Messrs. A. J. Blood-Smyth, M. F. Noonan, J. M. Collins, R. W. Ball (Fitt and Co.), W. Leahy.

DEATH OF MRS. DILLANE, GLIN

The death of Mrs. Matthew Dillane, Killeaney, Glin, which took place on Sunday very unexpectedly, caused a profound shock. The deceased attended the 8.30 o'clock Mass and on her return home she proceeded to carry out her ordinary household duties. She was taken suddenly ill and collapsed. Spiritual and medical aid were requisitioned, but death supervened after a short time. Very deep sympathy is tendered to her respected husband and children in their great loss. Rev. W. J. Carroll, P.P., and Rev. Fr. McCarthy, C.C., officiated at the graveside.

DANGER FROM TUBERCULAR MILK

WITHIN A YEAR OF THE PENSION

John Joseph Harrington, described as a travelling labourer, was charged in custody before Mr. H. L. Connor, D.J., at Kilmallock on June 24th, with the larceny of a lady's bicycle at Rathmore, Co. Kerry, on May 5th, and the property of Peggy Clery of the same place.

Sergt. Quirke, Rathmore, stated that the defendant was found drunk and was charged with the larceny of the machine, which he had in his possession. There was nothing previously against him.

Defendant said he was within one year of the old age pension and was never before in court. He was drunk when he took the bike and was sorry for it.

His Worship said that in view of the defendant's age and the fact that the bike had been recovered he would impose a suspensory sentence of six months imprisonment, not to take effect if he was of good conduct for two years. Inspector P. Pender prosecuted.

FORGOT TO NOTIFY THE GUARDS
