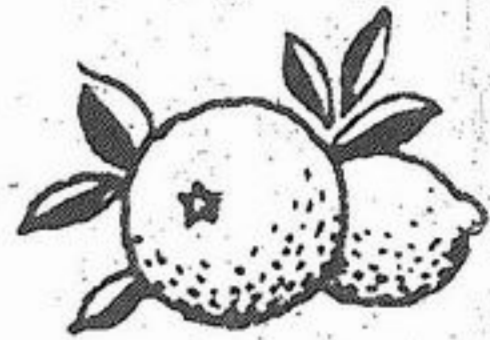

IMPORTANT.

TO ALL OWNERS OPERATING GAS PRODUCER PLANTS.

If reasonable precautions are taken to ensure that filters are efficient and regularly cleaned, and that the fuel used is suitable, then the engine wear will not be unduly excessive. If, however, plants are neglected, due to carelessness or ignorance, irreparable damage can be caused in a very short time. As well as regular attention to general cleanliness of filters and pipe lines, etc., particular attention must also be paid to the type of fuel used. Unsuitable fuel will lead to the production of detrimental by-products, chief of these being sulphur compounds and certain tarry matters. Wood charcoal is very free from sulphur compounds, but may contain a very excessive amount of tar, and, if the filters are inefficient, the engine will soon be damaged through sticking of piston rings, valves, and thickening of the lubricating oil. Anthracite, on the other hand, is reasonably free from tarry matters, but unsuitable grades may contain a very high sulphur content. This is more damaging to the engine, as the sulphur combinations in the gas have a very corrosive effect on all engine parts. After causing undue piston ring wear, the compounds escape into the crankcase, combining with the lubricating oil and corroding all working bearings.
