KILKEE LIFE-SAVING EQUIPMENT

(To the Editor, "Limerick Leader")

Sir-On Sunday, August 29th, a young man got into serious difficulty when swimming at Newfoundout, Kilkee. He was caught in a very heavy sea and was unable to get back. Some brave young Limerick men volunteered to go out for him. In the meantime I went for the lifebuoy which was hanging on a hook at Newfoundout. When I lifted it from the hook it broke into three pieces. I then, with some help, got out the life-line, only to find that the floats were dosed. These facts require no comment. The swimmer, by this time, had been swept towards the rocks under West Cliff, so that rescue from Newfoundout was out of the question. A further party of young men very bravely descended the cliff, and, under terrible difficulties, succeeded in reaching the swimmer. Fortunately, the life-line, which had been transferred to West Cliff, proved to be sound and by its aid the whole party was able to ascend the cliff.

I think it is a disgraceful thing to allow life-saving equipment to deteriorate to such an extent that it becomes a menace, and it is high time that visitors to Kilkee should have some assurance from those responsible that this equipment is something more than a dangerous ornament. It is also time to put up direction notices to swimmers at Newfoundout and at the Pier .--
