Mr. Keyes said that the allowances in respect of home assistance were too low. The ratepayers should face up to their responsibilities in this matter by having the allowances increased.

Mr. Casey-I recollect the Chamber of Commerce two years ago expressing a desire to have home

assistance increased.

NAMING OF NEW LIMERICK ROADS

Last night at a meeting of Limerick Corporation, the Mayor (Mr. J. McQuane) presiding,

The Assistant Town Clerk said that at a meeting of the special Committee appointed by the Council for the purpose of selecting appropriate names for the roads in the Prospect housing scheme it was decided to name the principal road after the President (Dr. Douglas Hyde), who was a Freeman of Limerick. It was suggested to name the other avenues after the following - Bob Byrne, Charles Kickham, Maurice Lenihan, Thomas Francis Meagher and Matt Talbot.

On the proposition of Mr. Keyes, the recommendation of the Committee was adopted unanimously.

Mr. A. J. Blood-Smyth, solicitor,

appeared for the N.S.P.C.A.

Patrick Mulqueen, in reply to Mr. Blood-Smyth, said that on September 7th his attention was drawn to the actions of the defendants, who had been employed by the E.S.E. to kill swans. Witness saw there following a swan in a boat and he saw Myers striking the swar with a pole. Lee was not striking the swan at all but was in charge of the boat.

The Justice said there was no evidence against Lee and he would dismiss the case against him.

Mr. Blood-Smyth said that the witness reported that the two men were striking the swan.

Mulqueen said he did not see Lee

striking the bird at all.

Mr. Blood-Smyth, in reply to the Justice, said the birds were supposed to be shot. There had been many complaints to the N.S.P.C.A. regarding the killing of swans, but it was only in certain circumsta ces the Society could prosecute.

Mr. Blood-Smyth said that if a swan was regarded as a wild bird he thought the prosecution could

not stand.

Justice-I will adjourn the case against Myers for a month and in the meantime you can look up the Act. I would be very sorry if there was not some law to protect swans as this is absolute cruelty.

The case was adjourned for a

month.
