

greyhound to rear and witness was on such friendly terms with him that there was never a question of payment. In January, 1943, Hayes was sent the bitch in question and there was no question of paying for her keep. Some time later Hayes told him the animal was in pup and witness considered her much too young and expressed his amazement that the defendant should have allowed this to happen as he (witness) intended putting the bitch on the track. Witness went later and took the greyhound away and subsequently plaintiff came and asked for £2 service fees, but made no demand for keep of the animal.

Cross-examined by Mr. O'Malley, witness said he never heard of anybody paying 10/- per week for the rearing of greyhound pups.

William Riordan said that it was in January, 1943, or late December, 1942, when Hayes got the pup. There was then no question of paying for the keep of the pup.

In reply to Mr. O'Malley, witness admitted it was common that when a person got two pups to rear he kept one and gave back the other. There was no question of two pups in the present case.

The Justice said that, in his opinion, both parties told their stories truthfully. He would hold that the greyhound pup was at Hayes's place with the defendant's knowledge, and he considered that plaintiff was entitled to payment for the maintenance of the greyhound. He would give a decree for £17. with £2 expenses.

### LIMERICK MAN TO GET £400
