His Lordship then went on to deal with the evidence in detail, and, having done so, the jury retired.

THE VERDICT

The jury, after an absence of two hours, returned to court with a verdict that Margaret O'Connor was guilty of being an accessory before the fact of larceny on 17th October. She was also found guilty of receiving stolen goods.

Both accused (Mrs. O'Connor and Wilson) were found guilty of conspiracy of stealing on 2nd November.

Wilson was found guilty of aiding and abetting Kelly of stealing on 2nd November.

Mrs. O'Connor was found guilty of being an accessory before the fact on 2nd November.

Mr. Kenny, on behalf of Wilson, for a certificate for applied leave to appeal on the grounds (1) that his Lordship was wrong firmary. in law in not directing the Jury that Kelly's evidence was not evidence against Wilson.
