## DEATH OF MRS. O'DONNELL

With very deep and sincere regret we chronicle the demise of Mrs. Dorrie O'Donnell, wife of Mr. T. E. O'Donnell, solr., which took place in a Dublin hospital on Saturday morning following a serious illness.

The deceased, a most estimable young lady, was the only daughter of the late Dr. James Roberts, who was one of the leading practitioners in Limerick for many years. A lady of high cultural accomplishments, she took a prominent part in the musical life of her native city. The possessor of a delightful voice, she frequently placed her talents at the disposal of charitable organisations. She was trained on the Continent and was one of the leading singers in the Brislane Choral Society. Mrs. O'Donnell was in private life a lady of great simplicity and charm, with a rare facility for making friends. had been seriously ill for the past fortnight and news of her demise has evoked widespread sympathy. Her death at an early age is rendered all the more poignant by reason of the fact that she leaves three young children.

To her bereaved husband, children, mother, brother (Dr. Michael Roberts), uncle (Rev. Father Aidan Roberts, O.F.M.), and the other members of the family we tender our heartfelt sympathy.

The remains were removed from the railway terminus yesterday at. 1.30 o'crock to St. Munchin's Church, whence the funeral took place today after Requiem Mass at 10.30 o'clock. On both occasions the funeral cortege was of striking proportions. Representative of all sections of the community, it was a wonderful manifestation of genuine regret and sorrow at the passing of a young lady who was deservedly held in such high regard and esteem by all classes.

Having heard argument from counsel on the question of loss, the Judge remarked that he failed to see how if a man received wages from a decent employer during an illness he could claim for loss under that heading. His Lordship had some doubt about the matter, but the practice appeared to be as stated by Mr. Liston in High Court cases. His Lordship gave a decree for £140 15s.

### COURT ORDER DISOBEYED

Before Judge Barra O Briain at Limerick Circuit Court to-day,

Knockadea, Daniel O'Mahony, Ballylanders, sought to have Patrick Keane, Knockadea, Ballylanders, committed to prison for disobeying a court order requiring him to quit lands at Knockadea.

Mr. T. K. Liston, B.L. (Messrs. D'Arcy & Co.), appeared for plaintiff; defendant was not represented.

Mr. Liston explained that at the Circuit Court, before Judge O'Donnell, the defendant was ordered to vacate lands at Knockadea, Ballylanders, the property of the plaintiff. An injunction was also obtained against the defendant and £10 damages awarded.

Mr. Liston read an affadavit made by plaintiff to the effect that defendant had failed to vacate the house and lands at Knockadea, or to carry out the order of the court. The plaintiff had bought the land and a house and got possession of the keys, but defendant also came along with keys and claimed that he had some title. He used come there every morning and go away at night.

Daniel O'Mahony, the plaintiff, said the defendant usually came to the land every morning, went to his dinner, and returned again.

Judge-Has he any stock on the land?-No.

Mr. Liston said that the notice of motion asked for committal or attachment. If the committal order was made it would mean that defendant would be arrested by the Guards and put in jail, and if the order for attachment were made he would be brought before the court to show cause. It might be more satisfactory if the defendant were brought before the court, as the plaintiff's object was not to punish anybody but to get possession of his lands. If the defendant were brought before the court he might see reason.

The Judge said that he would send defendant to prison for six months, or until further order of A 17 39 5 the court.

# ALL THAT WAS LEFT OF

Two bicycles, one minus tyres and tubes, and a third of which nothing was left but the frame, the other parts having been dismantled, were produced at Ennis District Court on Friday when a young man named Vincent Molloy, of Fergus Row, Ennis, was charged with stealing two bicycles, the property of John Barry, Loughville, Ennis, and of Mrs. G. McMahon, daughter of Senator T. V. Honan, Ennis. The defendant was also charged with receiving, knowing it to have been stolen, the third bicycle, the property of Francis Grey, Dundalk.

Mr. T. A. Lynch, solr., defending, indicated that there would be a plea of guilty.

The case was adjourned for a week and the accused remanded in custody.
