Mr. Tynan said that when the defendant originally agreed to pay the debt by instalments no mention was made of the 17/5.

Mr. O'Malley said that, according to plaintiffs own particulars, no goods were supplied to defendant on February 3rd.

The Justice gave a decree for the amount claimed in the civil bill. less 17/5.
