PRISON SENTENCE

At Limerick Circuit Court to-day, before Judge Barra O Briain, S.C., Timothy Walshe, Friarstown, Fedamore, was charged with the larceny of a coat, the property of a farm labourer named John McMahon.

Accused pleaded guilty.

Mr. T. J. Donovan, B.L. (instructed by Mr. J. J. Power, State Solicitor, prosecuted, and Mr. George Kenny, B.L. (instructed by Messrs. M. Tynan and Co., solicitors), ap-

peared for the accused.

Mr. Donovan, outlining the case, said that accused had been convicted on several occasions previously for larcenies and had served two terms of imprisonment. The coat mentioned in the present case was the property of a farm labourer who attended a dance at Kildimo in April. After the dance he missed the coat and reported the matter to the Guards, who discovered the coat on the defendant's land thrown behind a wall. In his statement accused stated that he

His Lordship said that accused had a rather bad record and he must impose a sentence of three months hard labour from the date of conviction.
