OBITUARY

**MR. MICHAEL M. RYAN,
THOMASTOWN CASTLE,
KILMALLOCK.**

The death of this most respected gentleman was heard of with feelings of poignant sorrow by a host of friends, but particularly by his comrades of the L.D.F., of which he was a most zealous and intensely practical member. He was a loving son whose ambition was to make life happy, and to those who knew him intimately he was the perfect comrade, well read, cultured and refined. The sympathy of the entire community goes out to his sorrowing mother and sister on the great sorrow they are called upon to bear. The deceased died at St. John's Hospital, Limerick, on August 22nd, and the remains were brought to Effin Church, from whence after High Mass, which was celebrated by The Venerable Archdeacon O'Brien, P.P., D.D., Effin, the funeral took place to the local cemetery on the 24th. The coffin, which was draped with the tri-colour, was preceded by a guard of honour and firing party of the following members of the L.D.F. under the command of Company Leader John Fitzgerald—W. Hannan, T. Donovan, M. Clifford, M. Fox, M. Ryan, P. Lyons, J. Wall, M. O'Sullivan, J. Prendergast, all in uniform. **WHAT MR. LAFFAN THINKS
OF IT**

(To the Editor, "Limerick Leader.")
Dear Sir—"Rambling Thady" wrote:

"The County Surveyor is scratching his hair,
And dreaming of sand-traps on
the Mulcair."

He might have added:

"The Limerick Ratepayers are in
deep despair:
Their money is gone with the
floods of the Mulcair."

We have a new County Council, deprived of most of their powers, it is true, but still left with the power of speech. I appeal to them as one of the many aggrieved to furnish us with all particulars as to the amount of money spent on the Mulcair drainage since taken over, and particulars as to the amount paid by the ratepayers, the amount levied this year, and the amount still due.

As to the success or otherwise of the scheme, suffice it to say that the July floods of this year destroyed and swept away the crops of the unfortunate people who are supposed to have reaped all the benefits of the Mulcair drainage.

To my mind, all our money has been spent "holing" in the central reaches where the detritus of the floods from the hill country lodges and chokes the river, hence the sand traps.

Your readers probably do not know that many years ago, probably sixty or seventy, after a cleaning up of the central reaches a big flood came down the river and flooded the country lower down, particularly the townland of Ballyguy. Law proceedings were taken and heavy damages awarded to the aggrieved parties, and the river was banked for miles as a result as far as the townland of Scart, only five miles from the outlet to the Shannon.

When Chairman of the County Council, I had the opinions of two well-known engineers that there is seventy feet of a fall from the Shannon mouth to Abington bridge, a distance around nine miles. At one particular place, Scart, there is a miniature Niagara—at least twenty feet in a quarter of a mile—where a trickle of water flows to-day. The Councilors ought go and see it themselves, only five miles from the city.

Why should not the County Council have a report and estimate of cost from our County Surveyor, in whom, and his assistants, the people have confidence, and acting on their advice proceed to open up the river from the Shannon to Abington? Seeing all the money expended so far, the cost would be very little in comparison.

If this course is adopted, and the Mulcair drainage made a success of, it will be open to the County Council, as well as the individual who has suffered losses by flooding, to institute law proceedings to recoup their losses. They will have at least as good a case as the late Mr. Nicholl, of Ballyguy, who recovered (it is said) eight hundred pounds under English law. I appeal particularly to the Castleconnell representatives to interest themselves. The Annagh river will also derive great benefit, as all local water will have gone before the hill water comes down, hence no more flooding.
