TWO ARRESTS

FOLLOW AN INQUEST

Following an inquest at Cappawhite, Co. Tipperary, on Saturday evening, on Thomas Woods, Glassdrum, Cappawhite, two arrests

were effected,

Woods, aged 40, was a carter employed by South Tipperary Co. Council. He died on Friday afternoon last following injuries alleged to have been received after a local dance on the morning of 25th November.

At the inquest Dr. McGrath, State Pathologist stated that the cause of death was coma, following abcess of the brain, resulting from inflammation, following a depressed fracture of the skull. The fracture was caused by violent impact with a somewhat pointed but blunt object.

In answer to Supt. Ward, the witness said that the injuries behind the left enr would be consist tent with " deceased having been

struck by a stone.

Dr. Hickey, Cappawhite, corroborated.

Supt Ward asked for an adjournment as there would be proceedings in another court.

The foreman (Mr. James Timony) acceding, the adjournment

was granted.

Some hours after the inquest, Supt. Ward arrested two young brothers, natives of Foilmacduff, Hollyford, Co. Tipperary, and farmer's sons, on a charge of the wilful murder of Woods. The accused men are Sean O'Dwyer (24), of Kilmoyler, Cahir, and Denis O'Dwyer (20), of Foilaclug, Cappawhite.

They were remanded in cutstody to Tipperary District Court on

Tuesday next.
