O'Connor, who did so much but did it quietly and unobtrusively, are, unfortunately, likely to be forgotten in an age when propaganda and the limelight obscure the facts of history. THEY HELPED IN I.R.A. DAYS

Mrs. Mary Enright, who died at her residence. Newpark, Croagh, on the 19th inst., was the relict of the late Mr. Thomas Enright. She was the mother of Mr. Chris. Enright, an active member of the I.R.A. during the War of Independence, and Mrs. W. O'Sullivan (then Miss Josie Enright), who also did her share as a member of the Cumann na mBan.
