GARDA ON MURDER CHARGE

To-day, at the Limerick District Court, before Mr. J. M. Flood, B.L., D.J. Dan'el Joseph Duff, a member of

the Garda Siochana, Pallasgreen, was again put forward on the charge of having murdered Garda James Byrne at Mount Catherine, Pallasgreen, on 25th September, by shooting.

Supt. Dunning, who appeared for the prosecution, said that as inquiries were still proceeding a further remand would be required.
