MR. D. CULHANE, "ROSEVILLE," CROOM.

The death took place at his residence, "Roseville," Croom, on Sunday evening last, of Mr. Dan Culhane. Deceased, who had been ill for some short time before his death, was a highly respected member of the farming community, and was held in the highest esteem by everyone who knew him. SCHOLARSHIP WIN

Mr. P. Maguire, Co.C., vice-chairman, presided at a meeting of Limerick County Committee of Agriculture on Wednesday. Other members present were Senator D. J. Madden, Co.C., and Messrs M. J. K. The C.A.O., Mr. M. Gleeson, was in attendance.

A letter was read from the Limerick Chamber of Commerce, explaining that at a meeting held recently in connection with the bacon industry it had been decided to invite the Minister for Agriculture to a conference in Limerick with all the interests concerned in the bacon industry. As the Chamber had been led to believe, through correspondence from the Department, that the Minister would come to Limerick, the Chamber now invited the Committee to appoint two delegates to attend this meeting with the Minister.

On the proposition of Mr. Hayes, the Chairman (Mr. J. Quaid, Co.C.) and the Vice Chairman (Mr. P. Maguire, Co.C.) were unanimously appointed as the Committee's delegates at the forthcoming conference with the Minister.

A resolution received from the Cappamore Co-operative Creamery Society, requested that the Minister allow a quantity of one barrel of wheat per head to producers, which would be held by millers, milled into flour and given to the growers as required.

Mr. Hayes considered the resolution very reasonable, and proposed that the Committee adopt it.

Seconding this proposition, Mr. Dore said it was only equitable that wheat growers should be given this advantage in view of the fact that creameries were permitted to give extra butter to their suppliers of milk.

The resolution was adopted without dissent.

THE BREAD RATION.

The C.A.O. said that he had received a reply from the Department of Industry and Commerce to the Committee's resolution asking for an extension of the supplementary bread allowance during the harvest period. The Department pointed out in their reply that in order to maintain the present general ration it would be necessary to restrict the issue of supplementary allowances to certain classes of agricultural workers.

Mr. Dore asked who were the certain classes of agricultural labourers referred to in the Department's letter?

C.A.O.—These are workers who have to travel more than two miles to their place of work.
