LICENCE GRANTED

The application by Ernest Corbett, of Bunratty House, for hotel licence for new hotel at Bunratty, County Clare, to be called the Castle Hotel, Bunratty, was granted by Judge Barra O Briain at Ennis on Friday, when his Lordship delivered reserved judgment.

The evidence and legal arguments in connection with the application

took up parts of six days.

Objection was taken by the Attorney-General to the granting of the licence on the usual statutory grounds, but at the close of the case on Saturday, 11th inst., the State Solicitor for Clare, Mr. M. J. Walsh, submitted that as the P.L. Valuation of the premises had not been revised the Court had no jurisdiction to hear the application.

At one stage of the argument, Mr. M. V. Fitzgerald, B.L. (instructed by Mr. I. M. Houlihan, solicitor), for the applicant indicated that in the event of the learned Circuit Judge contemplating refusing the licence, he requested a case stated to the Supreme Court.

Granting the application, the Judge congratulated Mr. Fitzerald on the skill with which he handled the case.
