### REDEMPTORIST ORDER'S LOSS

The death of Rev. James McLoughlin, C.S.S.R., took place very unexpectedly yesterday at St. Patrick's, Esker, Co. Galway. He was aged 62 years and was a brother of Rev. Michael McLoughlin, C.S.S.R., who was Spiritual Director of the Limerick Arch-Confraternity of the Holy Family over 20 years ago. His sister is Mother Abbess Bridget, Poor Clares Convent, Kenmare.

The late Father McLoughlin, who was a very brilliant priest, received his secondary education in the Redemptorist College, Limerick.

After his ordination in 1916 he laboured as a missionary in the Philippines.

## WIDE POWERS.

Section 57 of the Town and Regional Planning Act empowers the Corporation to either grant or refuse permission for the erection of any building within the "contiguous area," which has been clearly defined on specially prepared maps. The Corporation can, in fact, prohibit builders from proceeding with the construction, demolition, alteration, extension, repair or renewal of any particular structure. In view of these wide powers those who contemplate building should take the precaution of submitting properly prepared plans to the City Engineer (Mr. C. Stenson, B.E.). Failure to do so may result in considerable loss, financial and otherwise, to many.
