Dairy Cows and Heifers—The entry at to-day's market showed a substantial increase, the quality in both departments being excellent and, with buyers in good attendance, the better quality cows and heifers were keenly bid for, practically all this description changed hands. The secondary quality cows and heifers met a better trade and most of this description also cleared, the turnover and clearance being heavier than for some time. Top price for calved cows, went to Mr. John Cotter, Doorus, O'Callaghan's Mills, at £46, the runner-up being Mr. A. J. Hogan, Sixmilebridge, at £42. Top price for heifers went to Mr. Thomas Sheehan, Corbally, at £40. In calf and calved cows, best, £41 to £46; seconds, £36 10s. to £40; others, £30 to £35 10s.; small, £24 to £27 15s. In calf and calved heifers, best, £33 10s. to £40; seconds, £29 to £32 10s.; small, £24 to £28.

Store Cattle—The entry showed an increase as compared with last week and was well above the average for a July market; some excellent lots of store cattle were included in the entry and, with buyers in good attendance, a considerable portion of the entry changed hands, the younger classes meeting better trade than at recent markets; more of this description could have been sold. **DEATH OF MR. PATRICK
 GLYNN**

A widely popular citizen passed away on Sunday night in the person of Mr. Patrick Glynn, 72 Mungret Street. The deceased had reached an advanced age, being somewhat about the eighty mark. He had been in the employment of Messrs. Francis Spaight for sixty years or so, acting as stevedore for them for a very lengthy period. He represented the Irishtown Ward in the Limerick Corporation for several years, proving himself an unselfish and active worker in the interests of his constituents and of the city in general. He was also for a number of years a useful member of Limerick Harbour Board. The late Mr. Glynn was a man of many fine qualities and characteristics and enjoyed, as he deserved, the full confidence and esteem of all who knew him. An edifying member of the Arch-Confraternity of the Holy Family, he was a Golden Jubilarian of that great body. Of high principles, he was ever ready to help a good cause, and both in his private and public capacities he was held in very warm regard. To his bereaved family and relatives we extend our very sincere sympathy on his demise.

The remains were removed on Monday evening to St. John's Cathedral, where Requiem High Mass was offered up next morning. The funeral took place on Tuesday afternoon to Mount St. Lawrence Cemetery. Both at the removal of the remains and at the funeral the attendances of the general public were very large and thoroughly representative.

**GREATEST HANDICAP HORSE
