MUINTIR NA TIRE  
Co. Limerick Guilds  
MATTERS OF URGENT  
CONCERN

REV. FATHER McCARTHY, C.C., presided at the monthly meeting of Effin and Gardinerk Guild of Muintir na Tire, which was held on the 5th inst. There was a large attendance.

A letter was read from the Co. Council, in reply to a communication sent by the Guild, stating that the provision of a water supply for Effin National School is a matter for the Manager of the school and for the Department of Education.

After a discussion it was decided to postpone a decision to a future meeting.

PUBLIC PUMPS

Mr. Daniel Browne stated that an Inspector from the Department of Health called on him regarding the request for public pumps at Ballymac and Legane, and they visited Ballymac townland where they interviewed residents of the area. They inspected a place in the fields where cottiers obtained water. The Inspector called on him again on the Friday previous to the meeting and stated that his Department recommended to the County Council the necessity for a public pump at Ballymac and another at Legane. He suggested that the Guild again get in touch with the County Council and a letter has been sent requesting the immediate erection of two public pumps. The Guild would like to hear from the interested people where they would wish to have the pumps erected.

On the proposal of Mr. James Fennessy, it was agreed to write to the Department of Agriculture requesting that a veterinary inspector be sent to Effin for the purpose of giving a lecture on contagious abortion and mastitis.

REMOVAL OF HIGH BANKS

The meeting expressed their appreciation of the removal of high banks on the side of the road at Effin by a farmer on the Council, and decided that if land owners there will not remove the balance of the accumulation other steps will have to be taken, so that the road may be made safer for traffic.

Regarding the repairs to one mile of the Charleville road, a member stated that the machinery has been left two weeks idle on the side of the road.

It was decided to have a phone call made to the District Engineer to ask him why the work is not proceeding and also to ascertain if a short distance of the very bad road near Effin Cross will be steam-rolled.

The Council decided on writing the County Council again regarding repairs at Effin and Kilquane Cemeteries and requesting that the Engineer should come there without delay.

MANURE DISTRIBUTION.

It was stated that no grant has been allocated for the purchase of a manure distributor, and a lengthy discussion took place on the advisability of the Guild securing one on easy payments system. A letter was directed to be sent to a local merchant requesting favourable terms, particulars of which will be placed before the next meeting on November 2nd.

The matter of raising funds for repairs to the church roof was also under consideration. No decision was reached and it was adjourned to next meeting.

At the conclusion the meeting thanked Mr. John Cregg for attending to the secretarial work in the absence of the Guild's energetic secretary, Mr. Bertie Prendergast.
