Irish peak, according to a writer on the onlyloot, "to portionlarly stab in altrogan ; experi monte in gas making abow that it gives a much greater yield of autmonth than coal does, and consequently of the reculsing valuable fartiliser, sulphate of ammonta, as well as some valuable ash and par."

In large peak enterprises abroad-in thermany, Reesta and northern Italy-the peak is dug by mochantosi diagare, macersied so pulp, then briqueited or caked and further dried, if necessary, by natural sir-drying. In the scantcles mentionad, we read, " the bogs are first dialuad where poneible, and for big operasions the past is out by machinery, as stated. The brigasites are sold in towns as fuel."

With the peak problem selved, and cheap power produced, it is added, " industries will spring up as a natural consequence. Amongst them glass, porosists, brick,-tile, briquettes, pess charcoal, sulphase of ammoula, chemical sonstituants for the making of dyes, tauning material, etc."

Under a native Government all these things could be done, and there would naturally be immenses developments in a variety of other directions as well. The possibilities are certainly very great, and their more contamplation is sufficient in lessif to increase, and strengthen every genuine Isishman's desire to see his country enjoying the means of working out its own national and natural destiny in accordance with the wishes and aspirations and traditions of its people.
