



## Ban on Local Fails

Limerick city was the scene of tragic and sensational happenings during the week and, the loss of two lives and much destruction of property being involved.

The occurrences, it would appear, began in the John street district on Friday night. Some time before ten o'clock the unmistakable sound of an exploding bomb was heard pracblosliy all over the city, show being also heard. by shoss in Irishtown; bas, as carfew commenced soon afterwards, nothing was known till Saturday morning, when inquiry slichted the fact that an old man had been killed, four pollcemen and one or two sivilians wounded as a result. is was instanted by the police authorities, of firing at a patrol passing slong the street.

The official version of the occurrence is embodied in the following statement issued by Dublin Ossile on Saturday :--

"Au RIOpamol was fired upon in Johnstrees, Limerick, as 9 45 p m lass night. One head constable, two sergeants, and one constable were severely wounded. In addision one sivilian, an old man, was shot dead, and three civilians-a young man, & woman, and a hay - were wounded by she assackers' fire. In all there were eight passalties-one dead and

DISCOVERY OF DOCUMENTS

On Friday. in the King's Bench Division, befors Mr Justice Samuels, in the case of Arthur W Balding, of Collinstown; Leizlip, Oo Dublin, v Henry W Fields, Riversfield, Kilmallook, Co Limerick,

Mr Lordner (Instructed by Mesers Montgomery and Chayter), for the plaintiff, applied for an order for discovery of documents. The action was brought for the detention of the well-known polo pony, Missistos, and for damages for its detantion. During the war a man named De Vries had been living in the peighbourhood of Lucan, and a man called Barrie, who was afterwards associated with turf frands in Regland, came to the plaintiff, and, by representing that he was an agent of Do Vries, get possession of Mististos, and also a horse, for neither of which he paid the plaintiff. The plaintiff subsequently discovered that Barrie had no authority from De Vries. He succeeded in recovering, possession of the horse, but Mististes was purported to have been the subjeos of a sale by Barris to the defendant in the action. The plaintiff at once informed Mr Fields of his position in the matter, but the defendant continued to hold the pony. Oertain correspondence had passed in reference to the transmotion, the discovery of which was nocesary for the scial of the action.



### ORDER FOR PROBATE

Judge Dodd's Comment

Limerick Courtmartial Sentences

The following courimanial finding has been promulgated :-

John Orowisy and Michael Dwan, of Thurles. were each as Limerick sentenced to ten years' penal servitade. At Littleton. Conntr Tipperary, on 31st Ootober lass, an attack was made on the police barrack, which was sat on fire. This occurred about 5 p'clock and soon after wards preparations wass made for the desirussion of houses in the city. The largeet was that occupsed by Mrs M'Insensy, a double house on Lock Quay, in which, she cauled on the grovery and licensed business of her lass bueband.

Military amountion waggons arrived, and what looked liks atloks of gelignize fixed on a board were brought into the bouse. A wire was connected with an electric battery on Assembly Mall, A voice was heard calling out-" Is al clear?" A load explosion shook the entire neighbourhood, and the house crumbled in biss, burying faratures and stock in the debris, The force of the explosion cont a heavy entablasure bodily across the river, and a place of iton went through a window 50 yards away. Some hours afterwards this debris was found to be on fire. The fixnes spread to the adjoining house, that of Mrs Barrett. The Fire Brigada was rung up, and succeeded in confining the firs to Mrs Barrest's house, which was completely destroyed. The residence of Mr Patrick Bourke in Denmark street and of Mrs Nellan, John strest, were also demolished by the military. According to information which reached Limerick yesterday, a good many people from country districts who were in the city on Saturday were more or less seriously injured. when the streets were being cleared by Grown forees.





It is hereby agreed between the Nationalist and Republican (Sinn Fain) Parties of the Six Counsies-Autrin, Armagh, Derry, Down, Fermansch, Tyrone-that in the elections now regarded as imminent each party shall put forward in each constituency candidates to form an "Anti-Partition" slokes in accordance with the following conditions and schedula : (a) That all candidates accept the principle of "Self-Determination" for Ireland.

(b) That all candidates pladge thamselvas to abstain from the so-called Parliament of Northern Ireland.

That the respective parties agree to co operate during the election in such a way as will secure the united vote of the parties for the candidates standing upon the "Anti Partition" bloket. This co-operation shall be arranged so that the identifies of each party shall be preserved, and shall pherefore be secured by an interchange of preferences is the following manner, viz : Voters shall be asked to give their earlier preferences to the candidates of their own party, and their next immediate preference to all the candidates of the other party to this sgreement.



Cover with raising which nave been stawed. thickened and sweetened with one tableepoonful of sugar, Roll up the same as a jam roll, and bake fn a sin that has been bruched with butter. Sprinkle top with another tablespoon. fal of sugar, and dopowish the remainder of the butter. Bake in a moderate oven for 40 minutes, and serve with lemon sauce.
