

Tarbines are available which will do seefal work when the difference of level, or the "head," is no more than 3 feet. A certain amount of the power so generated would be converted into clastricity at once and delivered to users-put into the mains-but not all the power."

Provision, of course, has to be made for the supply of power to users during hours when tidal differences are not available to produce It. Therefore some of the power available when the tides serve is to be used to pump water from the river up to a high level reservoir constructed in a billy region on one side of the river.

The water, Mr Liversedge explains, "will ran down sgain through other turbines and develop power when the tide is not working. In this way it will be possible to supply power at any time of the day or night, whatever the state of the bide."

The number of pigs exported from Ireland during the same period was 588, and the total of killings and export was 37,571. As compared with the first week in May, the totals of home purchased animals in the third weak show a reduction of practisally one-fourth, while the exposte which were all in the first week jamped to hundreds in the second and dropped again last week. The total from the teginning of the year to dave is 420 845 as compared with 445,920 in the year 1919. The imports of pig products from places abroad during the period from 1.1.21 to 14 5.21 sotalied 2,676,176 owis, while in the corresponding period of 1920 the total owie was 2 120 194 chowing an increase of imports of 555,982. The total the year 1913 was 2,330,914 owts, or 345 262 ows less than this year's imports of pig produois, such as bacon, hams, pork, fresh, refri gerated and salved.

Refusal of Witnesses to Attend Inquiry

Mrs de Roiste said she would not stiend the court, and refused to take the anomons from him. The priests told him they could not be of any assistance to the court in the svidence shey had to give, as they were not present as the shooting. The head constable added that their evidence could only be hearsay.

The court adjourned for a direction from the Military Governor as to farther proceedings.




