

## DIES IN NEW YORK

The death of an old Limerick Gasl, whose demise we deeply regret to appoance, took pince recently in New York in she person of Mr Daniel Madigan. Deceased, who was son of the late Mr Owen Madigan, of Knrakaderry, Newcassle West; was for several years prior to his departure for the States employed in one of she monater drapery houses in the city and was highly respected by all classes. He was a prominent and valued mamber of the Limerick Commercial Football Olub, and was one of its leading players on one of the occasions on which is annexed All-Ireland Championship honours. He was also prominently identified with the Amnesty Movement, being an active member of the Limerick Amnesty Association. His brosher, Mr Marsin Madigan, who also resided save al years in Limerick, where he was an especial favourite, was regarded as one of the best careman of his day and was a mensber of a famous Elmerick " four " and as equally famous "eight" who won all before shem in their time.







These two forces are not equal in amount or parallel in direction; and hence there is usually a small differential effect, which tends to tilt the otherwise level perface of standing water now in one direction and now in another. In a small circular pond of still water the level would rise at the side nearest the moon, and fall correspondingly on the other side, provided the moon was above the horizon-otherwise it would be highest at the side opposite the direction of The (invisible) moon. As the moon swung around the sky from east to west, the high tide on the edge of the pool would follow it. It would be highest when the moon was forty-five degrees above or below the horizon, and would disappear when the moon was rising, setting, or directly overhead or undermeath.

In a lake 200 miles across the tide would rise half an inch above the mean level, and fall as low, giving a range of an inch. Tides of this sort have been detected in the Great Lakes by taking the average of readings ou the water level on many days, at the theoretical time of high and low tide, and so sliminating the effects of wind and weather. In the land-locked seas like the Meditetranean the tides are of much the same nature, and have a range of but a few inches, except in a few abnormal regions.



The tides therefore have a much greater range in some parts of the ocean than it others, and the time, as well as the height, of high water will cars from place to place; but the interval between successive high waters will be always exactly one-half of a lunar day.

The sun also gives rise to tidal forces, but owing to its great distance these are less thanin the case of the moon, and the corresponding solar tides are of smaller range. The interval between successive high waters for the solar tides is, of course, exactiv twelve hours. They will therefore alternately get in step with the lunar tides reinforcing these, and out of step, partially ., unteracting them. The former of these effects will evidently occur at the time of new monal, when the sun and the moon are close together in the heavens and are pulling on the sea in the same direction. It will also happen at full moon, when the solar tide has gained hall a day on the henar tide, and remforces the other high water. #### EXPLOSIVES FROM SUGAR.

Some particulars have been communicated to the German Chemical Society regarding the process developed during the war by the production of -spiestres from sugar. Glycorine was purchased from the sugar, the former being used as the initial product for trinitro-giveerine. The process is based on the fermantation of sugar.

It was already known that sugar, when fermented, produced minute quantities, of glycorine. The inventors found that the percentage of glycerine obtained was considerably sugmented by adding sodium sulphite to the fermenting bath. To a solution of one kilogramme of sugar in one hire of water they added 400 grammes of subhite, 10 per cent. of the sugar being allowed to turn into yeass; They then made sure that the yeast cells were | in a fit condition to carry on business. properly nourished or propagated. After two days the sugar had completely fermented. By suitably working up the liquid so obtained a giveerine suitable for all technical purposes was obtained.

The process was organised by a company and carried out by sixty-three works. After a lew difficulties were overcome, it was possible finally, from 100 parts of sugar, to obtain twenty parts of glycerine, together with twenty-seven parts of alcohol and three parts of aldehyde. One works produced 1,000 tone of giverine a month, the annual consumption of angar being 70,000 tons.

#### OIL FROM PEAT.

Oil is being distilled in New Zealand from Renri-gum peat, or puksu, which is part of the soil of the buried kauri forest saturated with the oil of the tree. The first plant, we are sold in the Universal Engineer (New York), began operations at Redhill. The plant is built to turn out 4,600 gallons of oil per week, | were imposed in sach (ase. its fractions being motor spirit, a valuable polyent oil, a turpetting substitute, and paint and versish oils. 100 movess of extracting the oil is very similar to distilling oil from shale. The cost of distillation is about the same, but the digging of the puksu from the swamp is infinitely cheaper than working a shale deposit, as pukau generally runs in bayers four feet thick, having only one foot of overearth. In the swamps large quantities of cil-soshed timber are found, which later will Elbewise be treated for oil. It is claimed that the bark, limbs, and roots of the kauri-tree are capable of yielding 110 gallons per toa. sicher than the pukeu itself, and it is estimates that the bast swamps carry five hundred fons of this oil-soaked timber. The supporters of this Redhill plant claim that the extracting oil from puksu will became the most imsortant industry in New Zealand, since there are thousands of acres of this swamp-land in the North Auchiand province, and each acre contains many thousands of dollars' worth of

Deprived of the cld Abbey in Ohurch. streak, the Friars were forced out of the district in 1679, but they still maintained an association with three elses in the town and three in sural localities. One of them was a building in Lycaght's lane, off L'arnell street, on the site of which the present bakery of Mrs Oronin stands. In the walls is being inserted a slab with an inscription in Irish, which reads in Erglish :- " Offer up a prayer for the souls of the poor Friare (of St Francis) who exercised the sacrad ministry in this house-s place where they found refuge in the Penal times." Another house in which they found a refuge is stated, to be the house at present occupied by Mies Olancy. and formerly occupied by the late Mr Molony as part of the licensed premises, in which the late Ray Bather Cahill, a Olareman, rabided until he was transferred to she old Bow Lans Chapel, so well known to former generations of Enpls people. where he died in the year 1882, we believe. There are some Ennis people yet living, though exceedingly faw, who remember the old building on the slie of the present Carroll's Bridge, whose rear want down to the river. It is proposed to mark this site a'so.
