


Demobolisation Ordered



Ounsel for the plaintiff-Mr M Elligott, K O, and Mr Blashy (Instructed by Mr P S O'Donnell) For the defendants-Mr Timothy O'Sallivan, K C, and Mr Phelps (instructed by Mr J S Gannay) The case of the plaintiff was that he was engaged as a servant boy with the defendants, shas shay, on ratarning from a fair as Pallas on the 24sh November, 1920, hid 2282 in a haggard; shas he was shreatened, was arrested, charged with stealing the money, and brought before the R M, by whom he was at once discharged. The jury returned a verdice for 280 for assault, but found defendants had not been accuated by malles.
